



APPLYING FOR A CERTIFICATE OF ORIGIN



- On the **Active Applications** page under **Apply for a new document** select a document from the **Apply for** dropdown list e.g. Certificate of Origin.

- The Certificate of Origin application page will then open. Here you will complete all the required fields for your application (see pages 2 & 3 of guide).
- Scroll down the page and you will see the **Attachments to Application**, here you can attach any supporting documents to your application. If you need your documents certified by the Chamber you need to tick the Certify box to the right hand side of the attachment.

- To the right hand side of the **Attachments to Application** you will see the **Invoice Details** section. Here you can enter:
 - Invoice number
 - The invoice amount (value of the shipment, if entered it may be used for statistical purposes by the Chamber)
 - Enter any Comments/Special Instructions for the Chamber

- Above the **Invoice Details** section you will see four action buttons:
 - **Save** – saves the application and allows you to keep working on the application
 - **Save Draft** – saves & closes the application (you will need to enter a minimum amount of information to use this, the system will prompt you)
 - **Delete** – will delete the application and all entered information
 - **Submit** – this will bring you to the processing options page in order to submit the application to your Chamber.

APPLYING FOR A CERTIFICATE ORIGIN



- 1. **Consignor** – Here you will select a consignor or if it's your first time using the system you will add a new Consignor. Click Add New Consignor & complete the required fields, the system will then save this Consignor to your Tradecert.com database.
 - 2. **Consignee** – Here you will select the consignee or if it's your first time using the system you will add a new Consignee. Click Add New Consignee and complete the required fields, the system will then save this Consignee to your essCert database.
 - 3. **Country of Origin** – Select the country of origin from the list and hit the Select button. To choose multiple Countries of Origin press the Ctrl button on your keyboard & use your mouse to select the countries then press the Select button.
 - Consignor Ref: - The Consignor Ref is your reference number and can be anything you wish, for example, some exporters use the shipment Invoice number. Note: If you enter a number in the Invoice number field towards the top right hand side of the screen this number will automatically populate the Consignor Ref box, however, you can edit it if necessary.
 - 4. **Transport Details** – Select your transport details. (Optional)
 - 5. **Remarks** – Include any special remarks. (Optional)
 - 6. **Items number, marks, number & kind of packages, description of goods** – You can type the descriptions directly into box 6 or if you ship the same goods repeatedly you can select the 'Add New Repetitive Text', complete the required fields and then press submit. The system will then save this Description to your Tradecert.com database.
 - 7. **Quantity** – Here you will enter the gross or net weight or any measures and quantities.
- When you have completed the application, scroll to the top of the page and press the yellow Submit button. This will bring you to the Processing Options page. (the system will prompt you if you have forgotten a mandatory field.
 - You will be given two options:
 - **Chamber Prints** – the application will be sent electronically to the Chamber & they will print, manually stamp and sign & post it back to you.
 - **Exporter Prints** – the application will be sent electronically to the Chamber, they will electronically stamp & sign it and it will be sent back to you via the system for you to print on plain white paper.

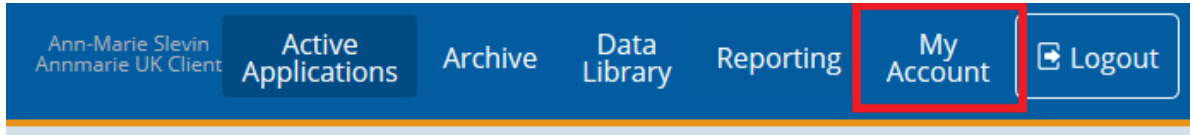

Printing your Documents:

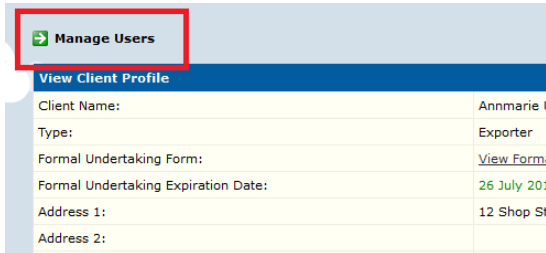
If you selected the Exporter Prints method you will receive an automated email from the Chamber when your application has been approved. To print your documents, click on the green Issue link beside the application on the Active Applications page. Follow the on screen instructions to print your documents.

ADDING ADDITIONAL USERS

- 1) Log in to your essCert.com account
- 2) Click on the 'My Account' tab.




- 3) Click the 'Manage Users' button.



- 4) Click the 'Add New Client User' button.



- 5) You can now enter the new user's details.



- 6) When you have finished entering the details press the 'Submit & Send Additional User Email' button at the bottom of the page.

- 7) To deactivate a user, check the tick box to the left hand side of their name, then go to the Activate dropdown list at bottom of the table and select Deactivate and press Go.




- 8) To edit an existing user, click the Edit link to the right hand side of their name, when their profile opens make the necessary changes and then press Submit to save the changes.


MANAGING CONSIGNORS AND CONSIGNEES

1) If you need to use a new Consignor or Consignee to your application it is very important you follow the steps below:

2) In the Consignor box, open the dropdown menu and select, Add New Consignee



3) When the New Consignor box opens you can enter the necessary details. When you have finished, press Submit to save the details. They will automatically be entered in the Consignor field and will also be available in the dropdown list for future applications.



4) Use the same steps for adding a new Consignee.

5) It is **extremely** important that if you need to use a new Consignor or Consignee, you do **not** select and existing Consignor or Consignee and then manually edit it in the box, this will result in false information being sent to your Chamber and may result in your application being rejected.

6) To deactivate a Consignor or Consignee, go to the Data Library page, select Consignors or Consignees.

7) Identify the record you want to disable from the list. There will be a tick box to the left hand side of the record, tick this box and then scroll to the end of the list. Here you will see a drop down list with the options Active and Deactivate. Select the Deactivate option and press Go.
